Economic Development Activities:

- <u>Marketing:</u> Staff met with a retail consultant to discuss future opportunities for Groton. There
 were also discussions with the City of Groton economic development staff regarding use of a
 dedicated "micro-site" on the <u>www.exploremoregroton.com</u> website to help serve the City.
- Thames River Innovation Place (TRIP): Staff participated with individual TRIP projects including Thames River Reconnection and Naval and Maritime Consortium. There was an innovation session at the RD86 kitchen facility in New London. Additionally, TRIP Board of Directors has been active in addressing a vacancy with the Executive Director position. We also have been meeting with the www.feedeachother.com startup group that might fit well into the TRIP model.
- Groton Economic Development Strategy: Town and City economic development staff
 coordinated by listing numerous future implementation steps that will ultimately be
 incorporated into the strategies document. The document will illustrate various priorities and
 recommend how they should best be implemented.
- <u>Fixed Assessment (Tax Abatement) Program:</u> The draft is still being reviewed by the Town Solicitor. It is anticipated that the Town Council will address the proposal in early 2019. It contains a tiered tax benefit structure based upon project size and benefit to Groton.
- <u>Economic Assistance Fund Applications:</u> Staff has been coordinating with three applicants seeking funding. Initial submittals are being refined for 18 Thames Street (office space), 255 Route 12 (retail/mixed use), and 5 Water Street. It is anticipated that the EDC Economic Assistance Fund Committee will review the revised applications in early 2019.
- Community Development Block Grant (CDBG): Staff attended a state CDBG workshop that
 addressed the potential for increased funding availability. We are preparing to seek funding
 exceeding \$1 million for 2019 focused on a two-year project budget.
- <u>Wayfinding Sign Project:</u> Staff coordinated a meeting on January 28th with the Thames River Heritage Park and City of New London to share the Groton Wayfinding Master Plan. Both groups were interested in pursuing the effort with their respective organizations.
- <u>Electric Boat Legislative Breakfast and Pfizer R&D Luncheon:</u> Staff attended the annual EB legislative breakfast on January 14th at which information further validated the present and

future growth EB. Staff also attended the Pfizer R&D luncheon presentation on January 28th where the increased growth and output of Pfizer reaffirmed their growth path. Pfizer's new CEO recently committed an additional \$500 million in resources to R&D alone. Groton's campus is the largest Pfizer R&D facility and holds the highest job retention rate. A number of key drug breakthroughs were described including several in oncology.

- <u>Public Property Redevelopment (Mystic Education Center):</u> Staff and the "preferred developer" met with the Town Council (COW) on January 15th. Public information regarding this pending project will be available in early 2019.
- <u>Public Property Redevelopment (Groton Heights):</u> Staff has been meeting and coordinating with the "preferred developer." Public information regarding this pending project will be available in early 2019.
- Public Property Redevelopment (517/529 Gold Star Highway): Staff has been further discussing
 the project with the "preferred developer" and assisting with project logistics. Public
 information regarding this pending project will be available in early 2019.
- <u>Public Property Redevelopment (Seeley School)</u>: Staff assisted in showing the property to prospects provided by the Goman + York commercial broker. Formal developer interests are anticipated in early 2019.
- <u>Public Property Redevelopment (Colonel Ledyard School)</u>: Staff is preparing advertisement materials for publication to begin active marketing. Cut sheet project information pages are now complete and will be uploaded on the web. An RFP release is anticipated by summer 2019.
- <u>Public Property Redevelopment (Pleasant Valley School)</u>: Cut sheet project information pages are now complete and will be uploaded on the web.
