ECONOMIC DEVELOPMENT DIVISION UPDATE

September 2018

The following summarizes economic development division activities for September 2018.

Economic Development Activities:

- <u>Marketing</u>: Monthly business articles have begun to be released on the web with the second release in September focused on "Fearless Flyers." The release is part of a nine business article series over time. Please "Like" and "Share" the posts on Facebook. Sharing really makes a difference to expand the reach. <u>http://www.exploremoregroton.com/groton</u>.
- <u>Thames River Innovation Place (TRIP)</u>: TRIP received Year 2 funding totaling \$620,000 to continue the regional economic development innovation initiative. Staff attended part of the September 17th and 18th Defense Trade Summit at the Mystic Hilton. The Consortium has been renamed the "Naval & Maritime Consortium" and it held the first meeting with suppliers on Wednesday, September 26th. Town of Groton staff participated. The "Thames River Reconnection" project selected Ninigret Partners to assist with the redevelopment project.
- <u>Groton Economic Development Strategy:</u> Staff has been working with Camoin and the City of Groton to develop an economic development strategy document. This addresses existing opportunities and constraints as well as ongoing project initiatives. The product will ultimately benefit Groton by formally defining priorities and implementation focus. A public meeting will be held on October 17th from 5:00 – 7:00 p.m. at the Town Hall Annex.
- <u>Tax Abatement Program</u>: Staff is progressing with this formal program. The general framework of the program was supported by the Town Manager and Tax Assessor. Next steps include fleshing out the narrative and future coordination with the Town Solicitor. The program will ultimately be presented to the Town Council for approval and will contain a tiered tax benefit structure based upon project size and benefit to Groton.
- <u>Enterprise Zone (EZ) Program</u>: Staff attended the quarterly statewide meeting on September 27th in Stamford. The state has recently approved funding their portion of the EZ tax exemption reimbursement, but only for the future year. The state did not honor its 40% exemption reimbursement for the current year.
- <u>Public Property Redevelopment (Mystic Education Center)</u>: Final rankings are being completed after the last round of interviews.
- <u>Public Property Redevelopment (Groton Heights)</u>: Several responses to the RFP were received. Staff is now reviewing the responses.
- <u>Public Property Redevelopment (517/529 Gold Star Highway)</u>: Discussion with a development team is ongoing.
